Terms and conditions of reservation

General terms

A booking can only be considered as confirmed following a minimum payment of 30% of the total value of the booking; the outstanding balance must be paid no later than 30 days prior to arrival. Failure to do so may result in the cancelation of your booking. In the case of bookings made via the internet, the balance will be automatically debited using the same card details supplied at the moment of reservation. For bookings made within 30 days of arrival the full payment will be required at the time of booking.

The payment of a deposit and or full amount of the value of the booking signifies acknowledgement and acceptance of the terms and conditions of Defiplanet' at Domaine de Dienné.

In the case of reservations made utilising, a gift voucher, gift box or similar the number of the voucher or box will be requested and must be supplied prior to confirmation of a booking.

All reservations which are made for dates which fall at the weekends must be a minimum of two nights, to include Friday & Saturday night or Saturday and Sunday night.

Cancellation insurance

Cancellation charges

Cancellation of your booking will incur the following charges:

More than 30 days to arrival	€ 15 cancelation charge

The day before arrival or in the case of non arrival 100% of the value of the booking

All cancellations must be received in writing either by email fax or letter the date of receipt of the same will be taken to calculate the cancellation

charge

In the case of reservations made utilising, a gift voucher, gift box or similar, the above cancellation terms apply. Where the applicable cancellation charges are 100% of the value of the booking we ask that you send us your a gift voucher, gift box or similar within 7 days of cancellation of the booking to Defiplanet' at Domaine de Dienné.. If we change your accommodation

Prices

Prices are correct at the time of publication and are for the current season. The contractual price will be confirmed by us at the time of booking.

Method of payment

Caution

On confirmation of your reservation a caution of 200 € per accommodation is required except Chalets, Gîtes and Maisons de Farfadets and Chateau where 300€ will be required the caution payment can be made by Euro cheque, which will be returned within fifteen days of your departure, or by supplying your bank or credit card details at the time of booking. We maintain the right to retain all or part of your caution in the case of damage to your accommodation or the facilities within le Domaine de Dienné.

Arrival & Departure

You may check in to your accommodation between 16:00 and 19:00 hrs. We ask that if your booking has been made using a gift voucher, gift box or similar this will be requested at check in. Should you be unable to present this documentation you will be requested to pay for the part or whole value of your trip equal to that covered by the voucher or gift box prior to issuing you with the key to your accommodation. Should you send us your voucher we will refund the amount paid. The activities are available at defiplanet starting at 9am depending on the schedule and you are welcome to take part in all activities prior to collecting your key.

You are required to check out of the property no later than 11:00 hrs however you may remain on site to enjoy the activities available.

Curtailment of your stay

Inventory

Cleanliness of your accommodation
